A LETTER FROM THE PRESIDENT

I hope you will forgive the implied language, but I recently ran across a very interesting book written by Jen Sincero entitled "You are a Bad***: How to Stop Doubting Your Greatness and Start Living an Awesome Life". I'm sure you can understand how one would be intrigued by such a title.

Within this self-help text, Sincero offers a short list of 10 ways to achieve "bad***-ery". I found myself returning over and over to one in particular.

EDUCATION

- Completed the fifth Leadership Etowah Class since 2008, graduating nine students.
- Developed the Discovery Café program to provide training to members on free or readily available business tools.

- Facilitated the foundation for a Felon Re-Entry Coalition to form in Etowah County.
- Participated in the Worlds of Work Career Expo.
- Served on local Career Technical advisory councils.

- Ran the second annual Belong Membership drive resulting in 53 new members.
- We hosted our third annual county-wide business expo that brought in more than 1000 attendees to visit 80+ vendor booths.
- In May, the Chamber, along with JSU's Center for Economic Development hosted a Small Business Capital Access and Matching Seminar.

COMMUNITY STEWARDSHIP

- Based on member requests, The Chamber hosted the very first nonprofit need matching drive in November.
- We hosted the third annual Advancing Women to the Top conference and based on wonderful reviews, plan to host the event again in 2018.
- We continue to advocate for area transportation needs, such as the extension of Interstate 759, the Southside Bridge, and other infrastructure needs

LEADERSHIP

- Began The Big 5: A Pathway to Progress to gather feedback and ideas about Etowah County from individuals throughout the area in order to develop a comprehensive plan for our community.
- Hosted roundtable events with Senator Luther Strange and with Attorney
 General Steve Marshall
- In 2017, The Chamber earned state accreditation by the Chamber of Commerce Association of Alabama. Additionally, Chamber President Heather Brothers New earned the Alabama Accredited Chamber Executive designation and the Institute for Organization Management designation.

EDUCATION

- Investigate the feasibility of a "junior board" consisting of college-aged individuals identified as potential leaders in the community.
- Produce an annual awards luncheon that recognizes true Excellence in Education throughout all systems from daycare through post-secondary.
- Establish a Chamber foundation that will provide education opportunities to promote economic prosperity and a strong workforce pipeline.

WORKFORCE DEVELOPMENT

- Advocate for technical courses that promote high level software development programs.
- Establish and assist in maintaining a professional network of human resource managers for the purposes of professional development and advisement of training needs.
- Develop unique sources of employee pipelines through determining obstacles to employment and identifying resources to overcome obstacles, such as felon repatriation, access to free transportation, training opportunities, homelessness and more.

ECONOMIC PROSPERITY

- Provide a Chamber council for the industry segments of nonprofits, finance and administration, human resources and marketing and sales professionals, for the purpose of sharing best practices and fortifying businesses and professionals serving in those respective roles.
- Provide monthly training opportunities, especially focusing on free technology, for small businesses to enhance small business operations.
- Advocate for #ShopSmallEtowah campaign as part of the Small Business Saturday campaign, as well as throughout the year.

COMMUNITY STEWARDSHIP

- Investigate a general public "taste of" event that would showcase restaurants, food suppliers and food product vendors from throughout the region.
- Consider an annual fundraising event to support the 501 c 3 Foundation once established; possibly a "Dancing With our Stars" concept.


LEADERSHIP

- Ensure fiscal responsibility and stewardship with special consideration given to furthering the payoff of the land lease with the City of Gadsden.


